## **Auspac Pure Water : Terms and Conditions**

### **A. Cooler Hire:**

1. Water coolers and water bottles remain the sole property of **Auspac Pure Water Pty Ltd** ("Auspac"). Any water cooler and water bottles not returned will be charged in full to the customer's account.
2. Water coolers must only be used for consumption of water supplied by Auspac. Failure to do so may result in damage to the cooler/s.
3. The customer is solely responsible for proper care, maintenance and cleaning of the cooler. In the event of any alteration or tampering of any cooler or part thereof, or any physical damage caused by the customer or theft, the customer is obligated to meet the cost of repair or replacement of the cooler.
4. The customer is responsible to give notice of any changes to the delivery address and/or contact details.
5. It is the responsibility of the customer to notify Auspac of any defective products and/or cooler/s within 48 hours of delivery.
6. The customer is responsible for notifying Auspac in writing before the end of the contract term if they wish to terminate their account, and to organise collection of the cooler/s and empty bottles. The unused period of cooler rental will not be refunded. If no notification is received by Auspac prior to the contract date end, then the rental agreement is deemed to be renewed for another 12 months under the same terms and conditions.
7. The customer authorises Auspac to debit their account for goods and services rendered or invoiced during the term of the agreement. This includes the contract renewal and during the rental period.
8. The customer consents to Auspac & or its contractors to enter premises to remove the cooler unit.
9. Auspac reserves the discretionary right to terminate a rental agreement should the terms & conditions of the agreement be violated.
10. Upon termination of the customers account, any remaining water or part thereof in bottles will not be refunded.
11. The customer will allow Auspac & or its contractors to enter their premises to collect cooler unit/s and any bottles upon the termination of account.
12. If cooler/s is not returned upon termination of account or upon expiry of the rental agreement, or if the customer fails to abide by the terms and conditions of this agreement, then a sum of \$500 for replacement and administration fee applies.
13. Interest is charged at the rate of 1% per month to all outstanding accounts not paid on time.
14. **This agreement also applies to all renewals following the original rental or trial period, and stays in force whilst the customer has possession of cooler unit and/or bottles.**

### **B. Bottled Water Delivery:**

1. A minimum order of 2 x 15L bottles is required per delivery.
2. Delivery is free provided it is made on the scheduled date.
3. **Unscheduled deliveries upon special request will attract an extra fee of \$33 per delivery.**
4. A \$10 refundable deposit per bottle is to be paid on the initial delivery. The \$10 per bottle deposit will be refunded at the termination of account provided all bottles are returned in satisfactory condition.

### **C. Ultra Pure Value Packs :**

1. The value pack has an expiry period of 1 year from date of issue.
2. Any quantity of water included in the cap that is unused will be forfeited at the expiry date.
3. The value pack is limited to one registered customer/company.
4. Upon expiration of the pack (1 year), any remaining water or part thereof in bottles will not be refunded, nor will it carry across to the next year.
5. Cooler Rental & Bottle deposits will be refunded once all goods are returned to Auspac in satisfactory condition.

### **D. Ultra Pure Recharges :**

1. \* Are available only to existing Auspac customers.
2. There is expiry period in which the water bottles must be redeemed.
3. The recharge is limited to one registered customer/company.
4. Cooler Rental & Bottle deposits will be refunded once all goods are returned to Auspac in satisfactory condition.
